The registration fee includes a fieldtrip T-Shirt for each child to be used at site.

Our summer program runs **6/1/10 – 8/15/10 Monday- Friday 6:15 am-6:00 pm**. Kids and Company recognizes that families take vacations during the summer. Please notify the office at 712-322-8800 if your child is gone for a week or longer. If your child will be gone for an extended period of time, please contact the office to be sure a spot is still available for when the child needs to return.

Meals: Kids and Company will provide breakfast and snacks. Lunch is provided by the school summer lunch program but we ask you to provide a sack lunch on days that the summer lunch program is not in session 6/1-6/3 & 8/1-8/15.

Childcare Fees: Your child care fees are based on the number of days your children attend. Our summer weekly charges are prepaid at a minimum weekly amount of 3 days for each family enrolled in the summer program. For convenience, there is the option of attending a 3 or 4 day week at a slightly higher daily rate.

Payment Expectations: Parents are expected to pre-pay for childcare services in advance. Parents may pay for childcare on either a weekly or bi-weekly pre-payment basis. Weekly invoices shall be provided to parents/guardians at the site by Wednesday of each week in estimation of services to be provided the following week. Please verify the accuracy of your invoice immediately. Please call the main office at 712-322-8800 x0 if you have any questions regarding your bill. Failure to keep accounts current will result in termination from the program.

Financial Assistance: The Iowa Department of Human Services may provide child care assistance to families at or below the gross income level listed in the DHS column below. If you feel you may be eligible for DHS assistance, please contact our office or the Department of Human Services for additional information.

If your gross income is above the DHS level, but does not exceed the CCS (Community Care Subsidy) column, and your children attend Kids and Company full time, please contact the office for possible assistance with your child care fees.
