Dear Kids and Company Parents:

We are so glad you are considering Kids and Company for your summer care needs! Below you will find information regarding the Kids and Company Summer Adventure Camp. Please complete the attached short form for your family and return, along with your \$15.00 non-refundable registration fee, to your Kids and Company site or to our main office in the Omni Centre.

Your child care fees are based on the number of days your children attend. Our summer weekly charges are billed at a minimum weekly charge of 3 days for each family enrolled in the summer program. For convenience, there is the option of attending a 3 or 4 day week at a slightly higher daily rate.

Please notify the office at 322-8800 if your child is gone for a week or longer. If your child will be gone for an extended period of time, please contact the office to be sure a spot is still available for when the child needs to return.

Payment Expectations: Weekly invoices will be provided at your program site on Wednesday of each week for services provided during the previous week. Payment is required within two weeks of the week of service. Failure to keep accounts current will result in termination from the program.

Meals: Kids and Company will provide breakfast and snacks. We will ask you to provide a sack lunch on days that the summer lunch program is not in session at the Pusey Elementary site 5/26-6/5 & 8/1-8/11.

Financial Assistance: The Iowa Department of Human Services may provide child care assistance to families at or below the gross income level listed in the DHS column below. If you feel you may be eligible for DHS assistance, please contact our office or the Department of Human Services for additional information.

If your gross income is above the DHS level, but does not exceed the CCS (Community Care Subsidy) column, and your children attend Kids and Company full time, please contact the office for possible assistance with your child care fees.
